# **OBSERVATIONS**

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Colorado Gravel Products Inc. site is located approximately four miles west of Center and accessed from Twelvemile Road. The site is a 112c operation that includes a total of 77.65 permitted acres. The Division currently holds a financial warranty amount of \$88,758.00 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is sufficient.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by fencing that was clearly visible and adequate to delineate the affected area boundary.

Mining was occurring during this inspection. The pit currently covers approximately 13 acres. The pit appears to be approximately 20 feet in depth. Pit highwalls are graded to approximately 3H:1V. Materials stockpiles are located throughout the pit area. Crushing/processing equipment is located in the southwest part of the pit. Topsoil is stockpiled in berms around the pit perimiter.

No problems or violations were noted during this inspection.
