The following inspection topics were identified as having Problems or Possible Violations. INSPECTION TOPIC: Signs & Markers

PROBLEM/POSSIBLE VIOLATION: Problem: The mine identification sign is insufficient. Weathering has caused the lettering to become illegible. This is a problem for failure to post a mine identification sign as required by Section 3.1.12(1) of the rule.

CORRECTIVE ACTIONS: The Operator shall, at the entrance of the mine site post a sign, which shall be clearly visible from the access road, with a minimum size equaling one hundred and eighty-seven (187) square inches, such as eleven (11) inches in height and seventeen (17) inches in width, with appropriate font size, with the following: the name of the Operator, a statement that a reclamation permit for the operation has been issued by the Colorado Mined Land Reclamation Board; and the permit number. The operator shall submit photo documentation that a proper sign has been posted by the corrective action date.

CORRECTIVE ACTION DUE DATE: 11/10/21

OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Whinnery Pit is located approximately eleven miles north of Lake City and accessed from Hwy 149 near mile marker 85. The site is a 110c operation that includes a total of 9.9 permitted acres. The Division currently holds a financial warranty amount of \$29,000.00 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is sufficient.

Adequate mine identification signage was not noted at the entrance to the site. The existing sign is weathered to the point that the lettering has become illegible. This has been notes as a problem.

The affected area was marked by posts and fencing that were clearly visible and adequate to delineate the affected area boundary.

Mining was not occurring during this inspection. Sand and gravel stockpiles are located on the south and west side of the pit. Mining equipment is parked near the stockpiles. The pit currently includes around four acres and is approximately twenty feet deep. Slopes around the pit range from 2-3H:1V. No stability or erosion concerns were noted. Topsoil is stockpiled on the south end of the pit. Overall, the site appears to be well maintained.

No other problems or violations were noted during this inspection.
