Tri-State Generation and Transmission Association Inc. (Tri-State), is the parent company to Axial Basin Coal Company, which is the general partner to Colowyo Coal Company L.P. (Colowyo). Therefore, Tri-State on behalf of Colowyo is submitting this adequacy response for minor revision 238 (MR-238) to Permit No. C-1981-019.

Tri-State received the Division's adequacy letter dated September 22, 2021, and has the following responses to the Division's concerns:

1. When reviewing Tables 13C-25 Collom Pit and Temporary Spoil Pile Topsoil and Table 13C-26 Collom pit and Temporary Spoil Pile Revegetation, the two tables have different increases in acreage form the currently approved tables. Table 13C-25 increases by 12.5 acres and Table 13C-26 increases by 9.5 acres. Please provided the Division discussion on the difference increased acreage between the two referenced tables.

Response: Table 13C-26 contained a typographically error which has been corrected.
