Dear Messrs. Padilla and Schultejann,

On September 24, 2021 the Division of Reclamation, Mining and Safety (DRMS/Division) was informed by Adams County a Notice of Violation had been issued by the Environmental Programs Division, see attached, to cease all recycling activities and remove from the site stockpiles of concrete and rebar.

The Division is aware that processing and recycling material was consistent with the approved reclamation plan. The operator is no longer able to process or recycle material therefore final reclamation must begin. Pursuant to Rule 3.1.3, all reclamation at the site must be completed in five (5) years.

RE: NOTICE OF VIOLATION ECI2021-00001 - Environmental Compliance Inspection

Dear Mr. Padilla,

The Environmental Programs Division is charged with the duty of performing environmental compliance inspections for the enforcement of Adams County Regulations. After reviewing the quarterly testing/materials results provided by Essential Business Solutions LLC on 8/16/2021, Adams County staff discovered that material is still being recycled at this facility. A site inspection of Henderson Recycling and Landfill was conducted, on 08/24/2021 by Adams County's Environmental Programs Division staff. Staff observed numerous semi-trailers delivering concrete material to the site.

The following violations of county regulations were observed during the site inspection:

VIOLATIONS:

Operating a recycling facility without a permit.

The facility must be brought into compliance. Complete the following corrective actions immediately:

- 1) All recycling activities are to cease immediately; and
- 2) stockpiles of concrete material and scrap metal/rebar must be removed.

All documentation of corrective actions taken to come into compliance with the above shall be sent to Adams County - Environmental Programs Division, 4430 S. Adams County Pkwy STE W2000B, Brighton CO 80601, or emailed to Miles Buescher, Environmental Compliance Specialist, at mbuescher@adcogov.org within ten (10) days of receipt of this letter.
