Incomplete Application**

Dear Mr. Wayland:

On August 4, 2021, the Division of Reclamation, Mining and Safety received your Amendment 2 Application package for the Goose Haven Reservoirs, File No. M-2010-071. Preliminary review of the information received determined that the following items must be received before the Division can consider your application as being submitted and a technical review can begin:

Application form

1. The application fee was not included with the application. The application fee is a requirement of the application package. See the application instructions attached to this letter. Invoices are not issued for application fees as your letter requested.
2. Item 9 of the application shows the location of the mine being in Township 2 N and Range 68 West. This information is inconsistent with Exhibit A of the permit and the Board Order of July 19, 2021. Please update page 2 of the application with the correct Township and Range.
3. Rule 1.6.2(1)(b) states that prior to submitting the application to the Office for a 112 Reclamation Permit (or amendment), notices (signs) must be posted at the location of the proposed mine site. You must also submit a signed certification that the sign was posted at the site. A sample of the required notice and certification is attached to this letter.
4. Page 6, Item 10 states that the Goose Haven project is a joint venture or partnership. Item 1 of the application shows that this operation is solely the responsibility of the City of Lafayette. Please update page 6 without #10 initialed or submit a power of attorney authorizing a representative.



Your 112 amendment application will not be considered submitted/filed until the information listed above is received and found sufficient to begin the review. A decision date will be established 90 days from the date of receipt and acceptance of all the requested information (Rule 1.4.8(1)).

Pursuant to Rule 1.4.1(8), you have sixty (60) days from the date of this letter to submit all necessary documents that the DRMS needs for an application to be considered filed. If, at the end of the sixty day period, the application has not been determined to be filed with the DRMS, the DRMS may deny the application and terminate the application file. All corrected pages must also be provided to Boulder County Clerk & Recorder.

The response to this Incompleteness Notice is due on or before October 4, 2021.

This letter shall not be interpreted to mean that there are no other completeness issues or technical deficiencies in your application. The DRMS will review your application to determine whether it is adequate to meet the requirements of the Act after submittal of all required items.

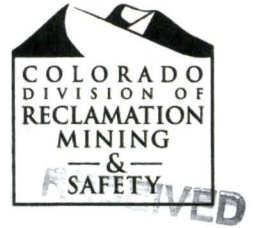
