Hi Calvin,

I got your voicemail. There are two options here:

Option #1 - provide Mr. Spady a copy of the required notice and afford him the required time period for comment. The date he receives the notice can be treated as the 1st day of "publication" and then three weeks later that day will be treated as the "last day of publication", and then the comment period will close 20 days after the last date of publication. DRMS will not be able to issue a decision on the application until the comment period closes.

Option #2 - Obtain a letter from Mr. Spady indicating that he is aware of the application/operation and that he does not have any comments or objections to the application.
