To Whom it may concern:

I object to the mining application referenced above for the reasons set forth below. I politely request that the application be denied by the DRMS Board. Stir water runoff from the ACME mine expansion and storage is an obvious concern for the Palustrine area, and also for the tributary of Van Bibber Creek just to the north. This tributary is mapped as a Zone AE on the FEMA floodplain, as well as on the CNHP wetlands mapper.

In the screenshots below, you will see a violation of Stormwater Planning assessed against ACME Brick. This does not instill confidence that our local watersheds will be protected by ACME's expansion plans.
