Dear Mr. Barton:

On October 29, 2021, the Division of Reclamation, Mining and Safety received your 112c Construction Materials Reclamation Permit Application package for the Oak Brush Hill Gravel Pit, File No. M-2021-064. Preliminary review of the information received determined that the following additional information must be received before the Division can consider your application as being submitted and technical review can begin.

1. Application Form- Responsibilities as a Permittee

- a. Page 5 and 6 of the application package contain the Responsibilities as a Permittee section that requires initialing in blue ink by the Permittee, this section was left blank in the wet signature copy of the application. Please provide replacement pages 5 and 6 of the application, initialed by the Permittee in blue ink.
- 2. Exhibit Q, Proof of Mailing of Notices to Board of County Commissioners and Soil Conservation District
 - a. Although a blank copy of the notice to be sent to the Board of County Commissioners and Soil Conservation District was included the proof of mailing the notices was not. Please provide proof of mailing the appropriate notices in accordance with Rule 1.6.2(1)(a)(ii).

3. Exhibit R- Proof of Filing with County Clerk and Recorder

a. A blank copy of the proof of filing with the County Clerk and Recorder was included with the application package. Please provide the executed copy of the proof of filing document demonstrating the application and all supplemental information was placed on file with the Archuleta County Clerk and Recorder in accordance with Rule 1.6.2(1)(c).

4. Addendum 1- Notice Requirements- Affidavit of Posting Notice

a. Please submit the required Affidavit of Posting Notice and photo documentation that the notice is posted, and meets the size requirements of Rule 1.6.2(1)(b) which states "Prior to submitting the application to the Office for a 112 Reclamation Permit, post notices (signs) at the location of the proposed mine site, as required by the Office, of sufficient number and a minimum size of eleven (11) inches wide by seventeen (17) inches high, with appropriate font size, to clearly identify the site as the location of a proposed mining operation giving name, address, and phone number of the Applicant, and stating that (name of Applicant) has applied for a mining permit with the Colorado Mined Land Reclamation Board. Anyone wishing to comment on the application may view the application at the County Clerk's or

> Recorder's office and should send comments prior to the end of the public comment period to the Colorado Mined Land Reclamation Office, and state the Office's address, as given on the cover of these Rules. For any class of 110 Limited Impact or 111 Special Operation, the Applicant need only post notice at the location of the proposed access to the site. After having posted such notice, failure by an Applicant to maintain such notice (sign) shall not constitute just cause to deny approval of the application. At the time the application is filed with the Office, the Applicant shall provide a signed affidavit that such notices (signs) were posted according to the provisions of this Rule."

Your application will not be considered submitted until all the information listed above is received and found sufficient to begin our review. You have sixty (60) days from the above date to submit all necessary documents that the Office needs for an application to be considered filed. All required information should be received no later than **Tuesday January 11, 2022**. If, at the end of the sixty day period, the application has not been determined to be filed with the Office, the Office may deny the application and terminate the application file.

This letter shall not be construed to mean that there are no other technical deficiencies in your application. The Division will review your application to determine whether it is adequate to meet the requirements of the Act after submittal of all required items.
