Hello All,

I just wanted to clarify the 12/23 decision date is the deadline DRMS has to issue a recommendation (to the Mined Land Reclamation Board) to approve or deny the application based on whether or not the applicant has sufficiently addressed all adequacy items identified in the application. This is not the date for any public meetings or hearings. The Pre-hearing Conference (Pre-HC) and Board Hearing have not yet been scheduled for this application.

The Pre-HC will be scheduled after the decision date and at least 10 calendar days prior to the Board Hearing. For example, based on a decision date of 12/23, the Board Hearing could potentially be scheduled for the February 16-17, 2022 Board meeting (a minimum 30 day notice of the Board Hearing must be sent to all parties). In this case, the Pre-HC would be held no sooner than the week of 12/27-12/31 and no later than the week of 1/31-2/4.

Given the upcoming holidays and the fact that we have not received the applicant's response to our preliminary adequacy review letter, it is likely the review period for this application gets extended again. Typically, the adequacy review period for a new 112 application such as this one will have more than one round of adequacy letters issued. Regardless, it is up to the applicant to request additional extensions as necessary to allow sufficient time to satisfy all adequacy items identified in the application.

I will continue to notice all parties of any change to the application decision date. Additionally, once we get to the point in the application review period at which a Pre-HC and Board Hearing can be scheduled, details of these meetings will be sent to all parties.
