Good afternoon, Patrick:

Please find ASCI's responses to the questions in the DRMS Additional Information Requested letter dated 12/10/2021 below:

DRMS Question 1 - ASCI Response: Per Speer Mining Resource Technical Revision No. 1 (TR-01), ASCI collects groundwater elevations from monitoring wells on a bi-monthly (once per every two months) basis. However, as discussed during our 12/10/2021 phone conversation, a specific schedule is not in place. Groundwater measurements have been collected more frequently than six (6) times per year (e.g., in 2021, groundwater elevations were collected in eight [8] out of twelve [12] months). To avoid confusion moving forward, ASCI will commit to a consistent schedule for collecting groundwater level measurements from monitoring wells at the Speer Mining Resource. To clarify, ASCI will collect groundwater measurements from monitoring wells during the following months of each year:

- February
- April
- June
- August
- October
- December

ASCI will continue to submit groundwater elevation measurements on an annual basis with the annual report.

DRMS Question 2 - ASCI Response: Please find the requested graph of groundwater levels for each monitoring well attached.
