Rule 5.03.2(5)(d) states:

An authorized representative shall immediately terminate a notice of violation or cessation order by written notice to the person issued the notice or order or his designated agent when such representative determines that all conditions, practices, or violations listed in the notice or order have been abated...

The Division terminates a Notice of Violation or Cessation Order when all conditions, practices, or violations have been abated. That is, it is terminated when the **problem** has been rectified and no longer exists. The processes for appeal of the Notice of Violation and the assessment of civil penalty are not affected by the notice of termination.

Re: West Elk Mine (C-1980-007) Cessation Order CO-2020-001 Request for Termination

Dear Mr. Norris:

Please find attached the termination form for Cessation Order CO-2020-001(CO) for the West Elk Mine. On October 19, 2021 Mountain Coal Company, LLC (MCC) submitted Minor Revision No. 456 (MR-456) for the West Elk Mine. MR-456 revised previously approved permit text and maps and eliminated all proposed disturbances in longwall panels SS-2, SS-3, and SS-4 in the Sunset Roadless area. With the Division's approval of MR-456, MCC is no longer permitted to conduct ground disturbing activities in the Sunset Roadless area, rendering the CO moot. Any new proposed ground disturbing activities in the Sunset Roadless area will require the submittal and approval of a Technical Revision. As you know, MCC does not maintain legal right of entry for the Sunset Roadless area. This includes any potential redisturbance of the recently reclaimed road spurs and drill pads for longwall panel SS-2.
