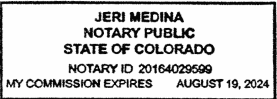

Hayden Gulch Terminal, LLC, 29515 Routt County Road 27, Oak Creek, Colorado 80467, has requested Phase I, II and III release of 170.3 acres of its re-claimed lands at the Hayden Gulch Loadout (CDRMS Permit No. C 1992-081, approved May 22, 1993).

The Hayden Gulch Loadout is located approximately 1.5 miles south of the Town of Hayden, Colorado. The specific area to which this bond release request applies within the Permit Area is located as follows:
T6NR88W:
Section 10 – Portions of: SENE, NESE, and SESE
Section 14 – Portions of: NWNW, SWNW, SENW, AND SW ¼
Section 15 – Portions of: NENE

The Hayden Gulch Loadout permit area consist of 391 acres. The USGS 7.5 Minute Quadrangle Maps Mount Harris, Colorado contains the described affected area. Pursuant to Rule 3.03.1, a permittee may request Bond Release upon completion of all surface mining operations in accordance with the approved reclamation plan, and the final inspection and procedures of Rule 3.03.2 have been satisfied. The approved reclamation plan can be viewed in its entirety in the Hayden Gulch Loadout Permit Application Package located at the Foidel Creek Mine Office, 29515 RCR 27, Oak Creek, Colorado 80467. Two Corporate Surety Bonds totaling \$1,107,240.91 are currently in place of which the bond amount to be released by this request will be determined by the Colorado Division of Reclamation, Mining and Safety.
