On January 26, 2022, the Division of Reclamation, Mining and Safety (Division/DRMS) received the Transfer of Mineral Permit and Succession of Operators Application for the Pickering Family Pit, File No. M-2009-086. The following items were determined to be incomplete with the application:

- 1. The Applicant submitted photocopies of the financial warranty documents with the application. Please provide original copies of all the required financial warranty documents to the Division.
- Please provide a completed copy of the Division's Documentation of Legal Authority to Execute Financial Warranty Documents form signed by both Nick & Caroline Waldow. - 3. The Division requires the application and warranty forms list the exact company name registered with the Colorado Secretary of State office, "Flintstone Gravel Pit Inc.". Please revise the company name on the application forms listed below to indicate "Flintstone Gravel Pit Inc." instead of "Flintstone Gravel Pit, Inc.".
 - a. Page 1 of the Application Form For Transfer of Mineral Permit and Succession of Operators Prospective Successor Information section
 - b. The first page of the Applicant's Agreement to Request Transfer of Mineral Permit and Succession of Operators form
 - c. The second page of the Applicant's Agreement to Request Transfer of Mineral Permit and Succession of Operators form - Prospective Successor signature section
 - d. The third page of the Applicant's Agreement to Request Transfer of Mineral Permit and Succession of Operators form - Notary for Prospective Successor section
 - e. The first page of the Performance Warranty form Operator name sections (two locations)
 - f. The last page of the Performance Warranty form Operator section
 - g. The last page of the Performance Warranty form Notarization of Operator's Acknowledgement



All completed documents are required to be submitted for consideration of the Request for Transfer of Mineral Permit and Succession of Operators Application. An incomplete application will be denied by the Division. Please provide the require documents to the Division by **March 3, 2022** to complete the application.
