During the Mined Land Reclamation Board (MLRB/Board) Hearing on January 19, 2022 the Division was directed by the Board to schedule, as soon as feasible, a hearing before the Board to hear Kelly Trucking's motion for relief from, and waiver of, civil penalties filed by Kelley Trucking on January 11, 2022 for the Watkins Mine permit no. M-2019-053. The item has now been scheduled for a Formal Board Hearing on February 16-17, 2022.

The hearing is scheduled for the February 16-17, 2022 Board meeting. The hearing will begin at 9:00 a.m. on February 16 or as soon thereafter as the matter can be considered. During the hearing, the Board will consider the motion for relief.
