Mr. Czapla:

On February 18, 2022, ACA Products, Inc. (Applicant) received comments (*Exhibit 1*) from the Division of Reclamation, Mining and Safety (Division) for the above referenced application on the behalf of Colorado Division of Water Resources (DWR). The following jurisdictional issues are addressed:

- 1. Exposure of groundwater will not occur during or after mining operations.
- 2. Currently, a specific storm water detention and infiltration structure is not anticipated to be constructed as part of this project. The intention is to have the pit mined in a manner that prevents surface runoff (stormwater) from exiting the pit limits and allow natural infiltration of stormwater. However, the Applicant is currently in the process of obtaining a stormwater permit with Colorado Department of Public Health & Environment (CDPHE). If it is determined during this permitting process that a specific storm water detention and infiltration structure is needed, the Applicant will coordinate with DWR to ensure notification, construction and operation meets DWR's statutory and administrative requirements.
- 3. All water used on-site will be from our existing facility located at 702 Gregg Drive, Buena Vista, CO. At a point in the future, we may apply and construct an onsite well to obtain water. Water used onsite will be for dust control and will be minimal in quantity.

CONDITIONS FOR APPROVAL

- The proposed operation does not anticipate exposing groundwater. Therefore, exposure of groundwater must not occur during or after mining operations.
- The application materials indicate that a storm water detention structure will be constructed as a part of this project. The applicant should be aware that, unless the structure can meet the requirements of a "storm water detention and infiltration facility" as defined in section 37-92-602(8), Colorado Revised Statutes, the structure may be subject to administration by this office. The applicant should review DWR's *Administrative Statement Regarding the Management of Storm Water Detention Facilities and Post-Wildland Fire Facilities in Colorado*, attached, to ensure that the notification, construction and operation of the proposed structure meets statutory and administrative requirements. The applicant is encouraged to use *Colorado Stormwater Detention and Infiltration Facility Notification Portal*, located at <u>https://maperture.digitaldataservices.com/gvh/?viewer=cswdif</u>, to meet the notification requirements.
- Other: All water used on-site shall be a legal supply of water provided by an appropriate supplier. The applicant shall confirm the legality of any proposed source of water supply with the Division of Water Resources prior to use in the operation.
