### **COMMENTS**

This was a partial inspection of the Foidel Creek Mine; DRMS Permit No. C-1982-056, operated by Twentymile Coal, LLC. (TC). This inspection was conducted by Tabetha Lynch with the Colorado Division of Reclamation, Mining, and Safety (Division). Nikie Gagnon with the Division was also present. Weather was cold and snowing at the time of inspeciton. Not all areas of the mine were accessible due to snow and drifing.

### GENERAL MINE PLAN COMPLIANCE:

At the time of inspection a grout was being mixed at the 7E cement drop pad. Fly ash trucks were hauling ash to the pad for the mixture. The grout/cement mixture will ultimately be mined out as the longwall passes through. Photos below of the work at the 7E pad.





Active roads were well plowed. Stream buffer signs and barrier were in place at the facilities area. Ponds were mostly snow and ice covered. Straw bales have been placed between the vent fan output and the access road to the ventilation pad. The water air was creating a visibility issue for traffic on the access road. Per the operator the bales are weed free straw. Shown below.
