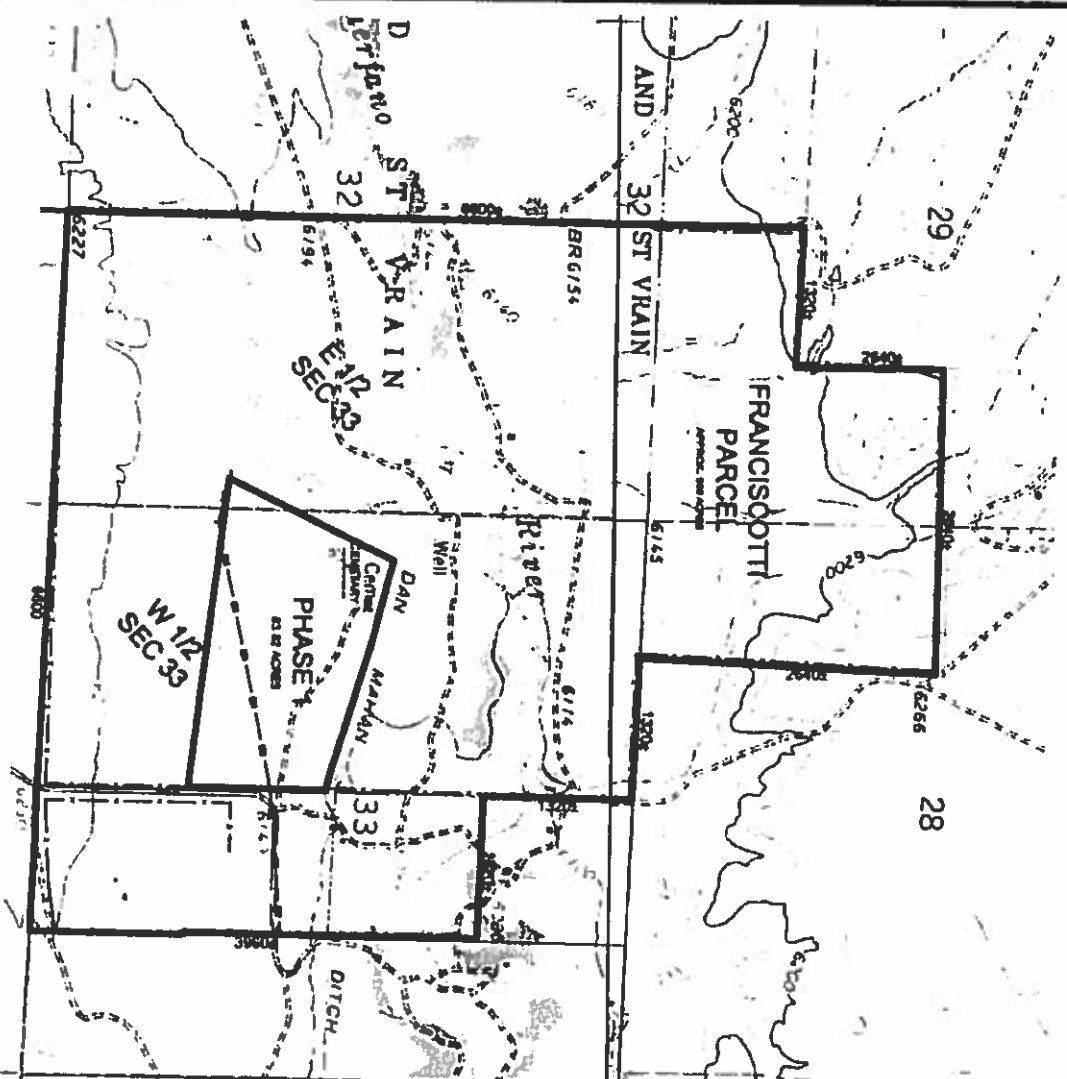

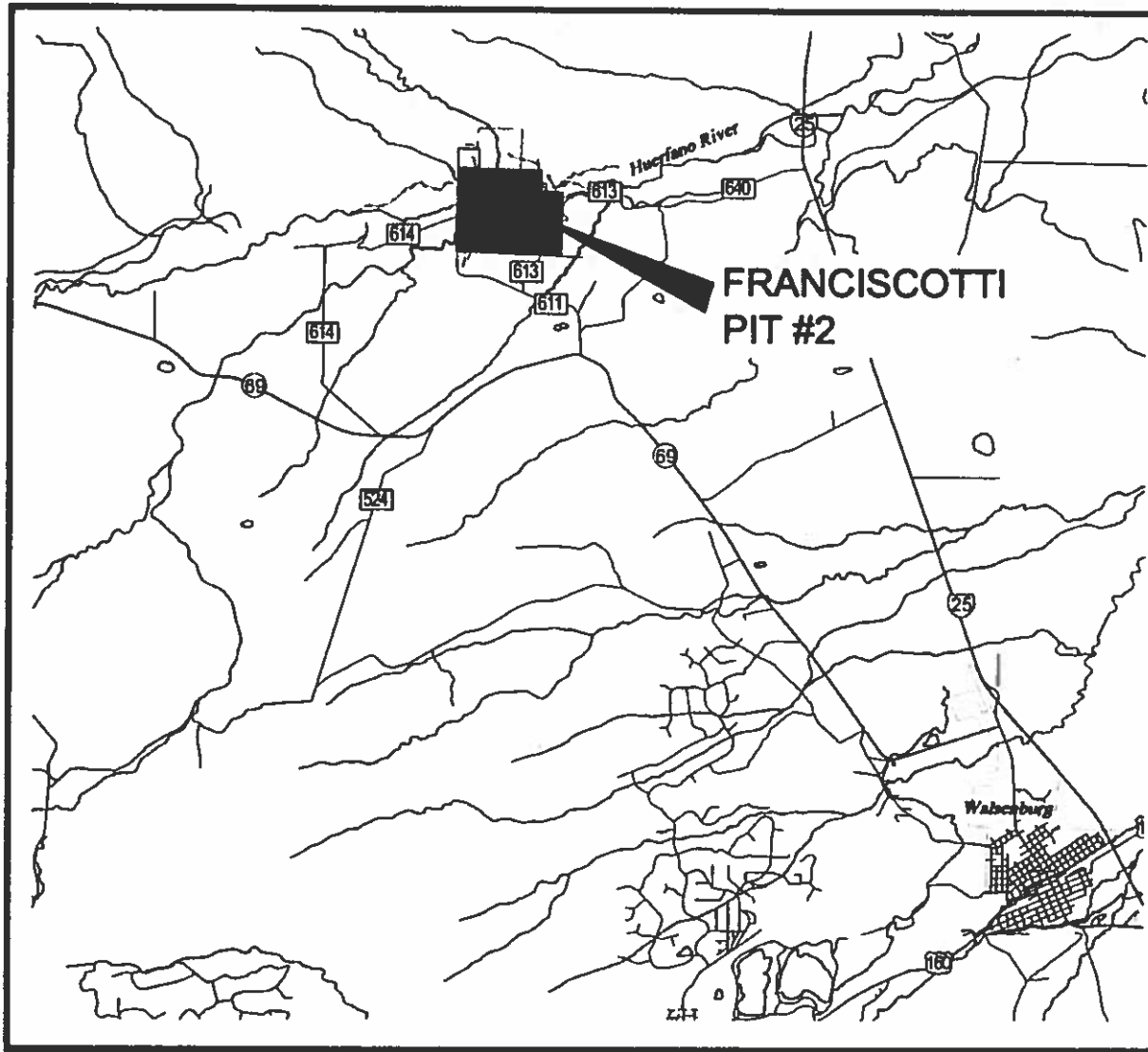
WEST OF THE 8TH PRINCIPAL MERIDIAN, COUNTY OF HUEFANO STATE OF COLORADO

N 73°14'22" W a distance of 1414.02', thence
N 76°16'21" W a distance of 982.29', thence
S 84°33'56" W a distance of 1161.68', thence
S 86°59'3" W a distance of 1261.60', thence
S 55°29'15" W a distance of 796.88', thence
S 0°56'38" W a distance of 841.78', thence
S 0°53'23" W a distance of 1324.05', thence
S 88°24'43" E a distance of 2367.07', thence
S 88°24'54" E a distance of 2344.51', thence
N 0°46'57" E a distance of 1174.05', thence
back to the P.O.B.

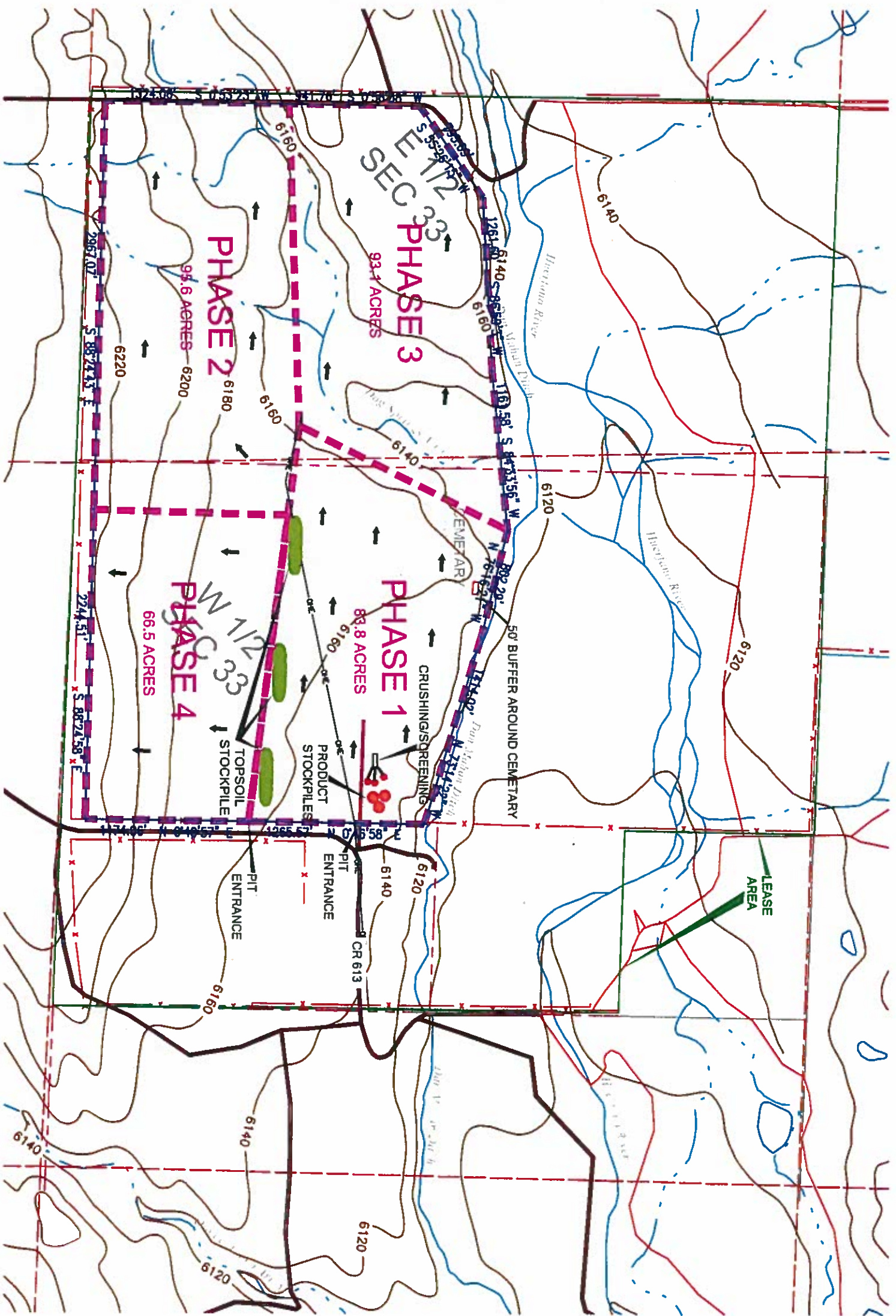
