Mr. Bennetts:

The Division of Reclamation, Mining and Safety (Division) is in the process of reviewing the above referenced application in order to ensure that it adequately satisfies the requirements of the Colorado Land Reclamation Act for the Extraction of Construction Materials (Act) and the associated Mineral Rules and Regulations of the Colorado Mined Land Reclamation Board for the Extraction of Construction Materials (Rules). During review of the material submitted, the Division determined that the following issue(s) of concern shall be adequately addressed before the application can be considered for approval.

1. The proposed permit area must include the access road to be constructed from Hwy 50 to the mine area. Please revise the proposed permit area to include the acreage that will be affected for construction of the access road.
2. Pursuant to Rule 6.4.1 (1), the Exhibit A - Legal Description must specify the affected areas. Please revise this exhibit to include the area that will be affected for construction of the access road from Hwy 50 to the mine area.
3. Pursuant to Rule 6.4.1 (2), please include with Exhibit A a map showing the main entrance to the mine site, and include the latitude and longitude coordinates of the entrance location from Hwy 50.
4. Pursuant to Rule 6.4.2, please revise the Exhibit B - Index Map to include the access road from Hwy 50.
5. Pursuant to Rule 6.4.3, please revise the Exhibit C - Mining Plan Map to include the affected area for the access road from Hwy 50. Please remove the label "Proposed Haulage Road" from the existing road connecting CR 140 and the mine area.
6. Pursuant to Rule 6.4.4 (j), please revise the Exhibit D - Mining Plan to include the required details regarding construction of the access road from Hwy 50.
7. Pursuant to Rule 6.4.5, please revise the Exhibit - E Reclamation Plan to include reclamation details for the access road from Hwy 50.



8. Pursuant to Rule 6.4.6, please revise the Exhibit - F Reclamation Plan Map to include the required details regarding reclamation of the access road from Hwy 50.
9. Pursuant to Rule 6.4.12, please revise the Exhibit L - Reclamation Costs to include costs for reclamation of the access road from Hwy 50.
10. Pursuant to Rule 6.4.14, please revise the Exhibit N - Source of Legal Right to Enter to include right of entry documents for each parcel crossed by the access road from Hwy 50.

Please submit your response(s) to the above listed issue(s) by Friday, April 01, 2022 in order to allow the Division sufficient time for review.

The Division will continue to review your application and will contact you if additional information is needed.
