Comments

SSSPG2. On June 15 discharge was less than 1 gpm resulting in elevated suspended solids and therefore elevated TR iron (144 mg/L). There have been no other monthly average TR iron exceedances at this outfall in the last three years. The elevated iron is likely the result of sediment at the base of the channel being disturbed during sample collection due to the very low flow conditions experienced during the June 15th sample. The iron measured in the following sample collected on July 6th was 0.52 mg/L, indicating the iron has returned to compliance levels.

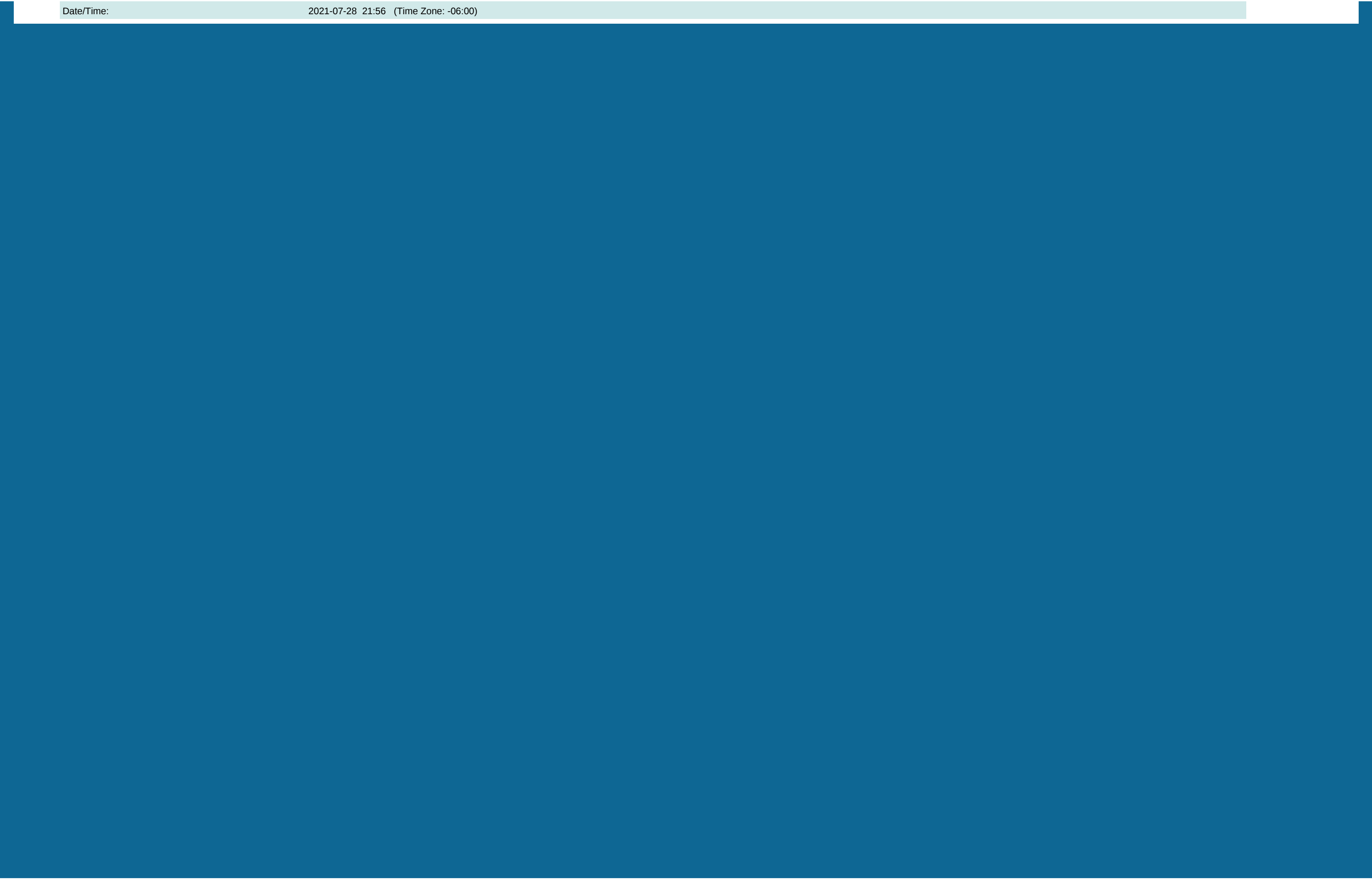
