These efforts started with containment berms on March 22nd, temporary repairs the same day, followed by permanent pipe repairs on March 28th. Dirt work clean-up commenced on March 28th, with final topsoil and seeding completed on March 29th.

This sodium bicarbonate barren brine leak was controlled at it's incipient stage. The leak was successfully bermed, containing the spill. This spill area is currently being reclaimed. A permanent repair to the pipeline is scheduled for next Monday, March 28th.
