Tri-State Generation and Transmission Association Inc. (Tri-State), is the parent company to Axial Basin Coal Company, which is the general partner to Colowyo Coal Company L.P. (Colowyo). Therefore, Tri-State on behalf of Colowyo is submitting minor revision 240 (MR-240) to Permit No. C-1981-019.

MR-240 proposes additional topsoil removal areas to support advancement of surface and highwall mining in the Collom Pit.
