On April 21, 2022 the Division of Reclamation, Mining and Safety accepted your NOI application for the Tallahassee Project in primarily Sections 4, 5, 6, 8 and 9, Township 17S, Range 73W, 6<sup>th</sup> Principal Meridian after having received your response to our second Notice of Deficiencies on March 23, 2022. The Division has also received and approved your Prospecting Financial Warranty for \$278,014.00.

The Division understands your activities will begin on or after March 1, 2022 and be completed by December 31, 2027. Pursuant to Rule 5.1.3(d)(IV), the Division's determination shall not take effect until the expiration of the five business days allowed for an appeal, or, in the case of an appeal, until the Mined Land Reclamation Board issues its decision.
