OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Miami Road Farm east of Montrose site is located on the east side of Montrose at approximately 38.478692°, -107.828710°, and can be accessed from either Miami Road or Sunnyside Road. The permit area includes 4 acres. It appears that excavation of the pit is complete and the operator has begun backfilling the pit with excess shale material generated from the development project on the south side of Sunnyside Road. Crushing equipment has been removed from the site. Processed gravel remains in the stockpile area. The operation appears in compliance with the approved mining plan.

No problems or violations were noted during this inspection.
