Ms. Gagnon,

I had recording to do at Adams County and while there I did some research with the Clerk and Recorder office and Assessor office. I think these may be applicable to the investigation you are doing. The points follow:

The Assessor is investigating now as there is no documentary evidence of land sale to CMH. As you found out, Turnpike said they had closed on the property last year. Adams County is not aware of a transfer. I have heard three different "close" dates from the former and alleged current property owners.

The recorder office said they normally record property transfer deeds the same day they get them and that record would be available within the week on their site. As of today the property is still listed under Turnpike.

Mr. Richard Huwa, the principal of Turnpike, told me in a conversation that he had a contract with CMH to retain rights to mine sand for other properties in his farming operation for the next growing season. Since ownership is in question and no permit exists, I suggest that Mr. Huwa may have entered into an illegal contract with CMH and may return for more material in the future. I request you inform them the pit is closed to them as well.

The property listing and transfers were done under the Hayden Outdoors realty group. My attorney for the Lost Creek GWMD indicated to me they have been problematic in the past with realty in this area and I am thinking perhaps there was intent to deceive by withholding documentation involved in this transfer so both could mine in the future.

I do not know if you were being nice about ignorance of the law in this regard at our meeting with the CMH representative, but Clayton corporate legal indicates to me that they do not allow or encourage questionable practices like this.
