Dear Mr. Markwardt,

On April 20, 2022, the Division of Reclamation, Mining and Safety (Division/DRMS) received a citizen complaint indicating that unpermitted mining was potentially occurring at a borrow pit and material was being transported to a new home site nearby to be used as fill. The Division conducted an inspection and the inspection report is attached.

As noted in the inspection report, based on the history of the existing pit and the amount of material moved by Clayton Homes, the Division will not pursue a violation for mining without a permit at this time. However, in the future, if any material is anticipated to be removed from the property, it is required that you complete an Is It Mining form (attached) and submit it to our office for an official determination of the proposed activities prior to initiation of the activities.

The Division would also like to bring to your attention that as of the date of the inspection, the Adams County assessor lists Turnpike Limited Liability Company as the current owner of the property. Please note that any agreement between Clayton Homes and Turnpike LLC to provide material from the pit for farming operations may require permitting action through the Division. This notice informs both parties that if material leaves the site without a mining permit in place, enforcement action will be pursued.

OBSERVATIONS

This inspection was prompted by a complaint received on April 20, 2022, by the Division of Reclamation, Mining and Safety (Division/DRMS) indicating that unpermitted mining was potentially occurring at a borrow pit and material was being transported to a new home site nearby to be used as fill. The complaint located the site in Section 3 T1S 63W, one half mile west of Highway 79 on Weld County Road 2. The Division conducted a records search and determined no mining permit exists at this location. Todd Denning, the complainant, is an adjacent landowner concerned about the excavating activity causing severe erosion to the county road and impacting groundwater. Nikie Gagnon and Jason Musick represented the Division during the inspection and were joined by Justin Markwardt, representing Clayton Homes, the company responsible for moving material off site. Todd Denning was present at the start of the inspection to relay his concerns to Mr. Markwardt but did not stay for the duration of the inspection. The weather was clear and sunny.

The Division reviewed Google Earth imagery which shows a borrow pit at this location since the early 2000s. The borrow pit has expanded over the years and the disturbance area is currently 1.21 acres (Photo 1). The Division contacted Richard Huwa of Turnpike LLC, who is listed as the property owner on the Adams County Assessor website. Mr. Huwa stated that he sold the property to Clayton Homes in November 2021. When asked about the borrow pit, Mr. Huwa stated that he routinely excavated material from the pit to fill sprinkler tracks on the property. According to Mr. Huwa, the Division was called out to investigate this practice in the past and determined that he was not mining because excavated material did not leave the property. No records were found in the DRMS permit system to confirm a previous inspection, however, Todd Denning, the adjacent landowner and complainant, acknowledged that the pit has been there for years and previous owners used material from the pit for agriculture practices. Mr. Denning's current concern with the activity is that the material removed from the pit was trucked off-site by the new owner, Clayton Homes, and groundwater could be impacted if Clayton Homes excavated any deeper into the pit. Although Mr. Denning stated in the complaint that the illegal mining of sand and soil is occurring in the West Sand Creek waterway, the Division determined West Sand Creek is approximately 400 feet east of the pit (Photo 2). Imagery of the area shows a ditch that intersects the south highwall of the pit (Photo 2 & 3). During the inspection, there was no evidence of exposed groundwater or stormwater in the pit.

Google imagery from April 20, 2021 and GPS points taken during the inspection shows the boundary of the pit wall has not expanded since Clayton Homes purchased the property in November, 2021 (Photo 1). During the inspection, Justin Markwardt confirmed that Clayton Homes removed ten truckloads of material on one day during the previous week and drove it to a home site approximately 5 miles north of the borrow pit. The fill material was removed from the northwestern side of the pit (Photos 5 & 6). Justin Markwardt estimated that the amount of material was 250 cubic yards (25 cubic yards per truck). Justin Markwardt stated that Clayton Homes was not aware of the requirement for a permit to move material between properties and now that they are informed of the process, the company has no plans to submit a permit application to mine the borrow pit.

Based on the history of the existing pit and the amount of material moved by Clayton Homes, the Division will not pursue a violation for mining without a permit at this time. However, the Division informed Clayton Homes and Turnpike LLC of the requirement to obtain a permit to remove material from the property. If any similar activities are anticipated in the future, it is required that the contractor complete an Is It Mining form (attached) and submit it to our office for an official determination of the proposed activities.
