OBSERVATIONS

This inspection was conducted as part of the Colorado Division of Reclamation, Mining and Safety normal monitoring program. The Lumsden Canyon Pit is a 110c permitted site located off 4 1/10 Road, less than one mile east of Gateway, Colorado in Mesa County. Amy Yeldell of the Division conducted the inspection. No represented from Mesa County was present. Brittany Cocina of the BLM Grand Junction Field Office were also present during the inspection.

The mine identification sign and affected area boundary markers are in place and in compliance with Rule 3.1.12. The mine sign was placed at the access road off of 4 1/10th road. The permit boundary is delineated by several t-posts.

The pit was inactive at the time of the inspection and appears to be in final reclamation. No equipment, fuel, structures or other mining related debris was on site. All highwalls have been sloped and revegetated. Pit slopes have better established vegetation with larger shrubs and some trees. The pit floor consists of primarily grasses and small shrubs or forbs. The two track access road bisects the pit floor which results in additional traffic to the reclaimed areas but overall vegetation appears resilient. The site conditions comply with the revised reclamation plan approved under TR-1. Cheatgrass and Russian Thistle was observed on site however they are also present in undisturbed areas adjacent to the site. Overall reclamation success is comparable to adjacent undisturbed areas.

Based on this inspection the Division has determined that the Operator has successfully complied with the requirements of the Act, Rules and Regulations, and the approved Reclamation Plan, and that the permit area is ready to be released from any further reclamation responsibility. If the Operator submits a surety release request (SL) within 60 days this inspection will count as the release inspection. Form is attached. Please note that a separate release request should also be submitted to BLM in order to terminate both permits.

No problems or violations were noted during this inspection.
