In correspondence dated March 17, 2022, GCC Energy, LLC (GCC) submitted to the Office of Surface Mining Reclamation and Enforcement (OSMRE) a permit renewal application for the King II Mine Federal Permit CO-0106C. In accordance with the regulations at 30 CFR 774.15(b)(1), an application for renewal of a permit shall be filed with the regulatory authority at least 120 days before expiration of the existing permit term. The active permit term has an expiration date of April 17, 2022. A timely review period required that GCC submit the proposed application to renew on or before December 17, 2021. For this reason, OSMRE administratively delayed its decision by email dated March 18, 2022. GCC submitted the complete permit renewal application package on May 16, 2022.

The Office of Surface Mining Reclamation & Enforcement (OSMRE) has determined that this application is administratively complete for the purpose of inspection by the public and review by applicable local, tribal, and federal government agencies. The application proposes to renew Permit CO-0106C for a 5-year period, April 17, 2022 thru April 17, 2027.

GCC must publish its public notice of the renewal application in a newspaper of general circulation in the locality of the King II Mine as per your revised notice received via email by this office on May 16, 2022. At a minimum, these notices must contain the information required at 30 CFR 773.6(a)(1) and must appear in these publications at least once per week for four consecutive weeks.

Upon publication of the fourth newspaper notice, please forward to OSMRE proof of publication documentation as a confirmation that these requirements have been met. As should be reflected in the language of these notices, the public comment period is to commence upon publication of the first notice and is to continue a minimum of thirty days after the fourth and final public notice.

As per OSMRE's review of the draft public notice, it is understood that a copy of the Permit Renewal Application is to be made available for public inspection at the following location:

As a reminder, it is required that GCC ensure that the application is accurate and complete, and made available for public review on or before the day of the first newspaper notice is published and remain so throughout the public comment period. Please be further advised that, should any subsequent changes to this application occur during the course of OSMRE's technical evaluation of the document, these modifications will need to be immediately placed with the publicly available copy.

In correspondence dated March 17, 2022, GCC Energy, LLC (GCC) submitted to the Office of Surface Mining Reclamation and Enforcement (OSMRE) a permit renewal application for the King II Mine Federal Permit CO-0106C. In accordance with the regulations at 30 CFR 774.15(b)(1), an application for renewal of a permit shall be filed with the regulatory authority at least 120 days before expiration of the existing permit term. The active permit term has an expiration date of April 17, 2022. A timely review period required that GCC submit the proposed application to renew on or before December 17, 2021. For this reason, OSMRE administratively delayed its decision by email dated March 18, 2022. GCC submitted the complete permit renewal application package on May 16, 2022.

Approval of this application would renew the King II Mine permit for a five-year term, April 17, 2022 to April 17, 2027. OSMRE uses the administrative completeness review to determine if the proposed Permit Renewal Application contains all the requirements of 30 CFR 774.15.
