

Please accept the following commitments to the items presented in the above referenced adequacy review of Exhibit G.

## 6.4.7 Exhibit G - Water Information

- Item 1: Zephyr accepts the Division's comment and intends to monitor both quality as well as quantity in surface streams.
- Item 2: The table label was corrected to 2.7.4-2. The applicant intends to compare analytical results to the standards listed in Tables 2.7.4-1 and 2.7.4-2.
- Item 3: The narrative is revised to reflect two monitoring locations on Grape Creek.

## **QAPP**

- Item 4: Table 5.2 is the same as Table 2.7.4.1-1 and is now in Section 5 of the QAPP as Table 5.2.
- Item 5: The five quarters of baseline water data will be completed prior to submitting the new application. At the end of the five quarters, semiannual monitoring and sampling will be conducted from the end of the baseline study to final approval of the mine application. Subsequent monitoring and sampling will be included in Exhibit G's Water Quality Monitoring Plan.
- Item 6: Section 6.4 is revised to reflect a minimum of 3 casing volumes or water-quality-indicator parameters data stabilizing prior to sampling. Zephyr commits to using the Division's guidelines for monitoring well purging.
- Item 7: Section 6.5 is revised to include Section 6.5.1: Ground Water Sampling and Section 6.5.2: Surface Water Sampling. Zephyr commits to sampling according to these guidelines.
- Item 8: Zephyr commits to collecting at least one surface water duplicate and one groundwater duplicate sample per quarter. QAPP Section 9.1.1.3 is revised accordingly.
