The Mountain View Pit is located on the south side of Crested Butte and accessed from a dirt road at the end of 9th Street. The site is a 110c operation that includes a total of 9.1 permitted acres. Pursuant to Rule 4.1.2 (2), the Division does not hold a financial warranty for this site.

Adequate mine identification signage was noted at the entrance to the site.

The site is in final reclamation. The highwall appears stable and vegetation is becoming well established. No erosion features were noted. Noxious weeds were not observed.

No problems or violations were noted during this inspection.
