**INSPECTION TOPIC:** Backfilling & Grading

**PROBLEM/POSSIBLE VIOLATION:** Problem: Trash and refuse was noticed on the site. This is a problem at this time for failure to dispose of refuse in a manner that controls unsightliness or deleterious effects of such refuse pursuant to C.R.S. 34-32.5-116(4)(e).

**CORRECTIVE ACTIONS:** The operator shall submit a written notice to the Division with photo documentation, that the trash has been removed from the site by the corrective action date.

**CORRECTIVE ACTION DUE DATE:** 8/01/22

## **OBSERVATIONS**

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present during this inspection. Photographs are included with this report in order to illustrate some of the conditions observed.

The Hollenbeck Pit is located approximately five miles east of Gunnison and accessed from CR42. The site is a 110c operation that includes a total of 9.9 permitted acres. The Division currently holds a financial warranty amount of \$19,029.00 for this site. The Division will review the reclamation costs in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan. The Operator will be notified under separate cover if the Division determines that the current financial warranty amount is insufficient.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by t-posts adequate to delineate the affected area boundary.

Much of the highwall has been backfilled to 2-3H:1V.

No fuel storage was noted on site. Noxious weeds were not observed.

Various construction waste material and refuse has been brought to the site, including ceramic tile, used asphalt and concrete, lumber, wood and furniture. **The Division considers these items to be a reclamation liability and a problem for Operator's failure to dispose of refuse in a manner compliant with C.R.S. 34-32.5-116 (4)(e). This material must be removed from the site by the corrective action deadline noted on page one of this report.**

No other problems or violations were noted during this inspection.
