Please accept this email as a point of concern and objection to Raptor Mining's request for permits regarding the Two Rivers Sand, Gravel & Reservoir Project.

As a resident in the Dos Rios Neighborhood, I am concerned that our neighborhood wasn't notified of a significant project such as this, nor giving us the opportunity to learn more about the project and provide an opportunity to express our concerns before it became a last minute effort. The impact this project and ongoing business would have includes increased traffic on a residential road, creating dust and increased noise, as well as making additional road maintenance a probability. It would significantly effect and upset the wildlife that make their homes in this area, including many wild turkeys, guineas, deer, bald eagles, and we've even seen bobcats and a great horned owl.

I don't know how this project might affect the river itself but many hours were spent recently on this river, including efforts to protect some endangered species.

54th Street Road has already experienced increased traffic with drivers traveling through this corridor going too fast. Add multiple big trucks to the mix with a limited ability to slow their speed quickly would be disastrous to the wildlife that live here!

I would respectfully request your consideration of how this project will impact this area in hopes there may be better options for Raptor Mining and the Two Rivers Sand, Gravel & Reservoir Project.
