## **COMMENTS**

A partial inspection was conducted by Rob Zuber of DRMS on June 8, 2022. No BRL staff were present.

No mining or reclamation activities were being conducted at this site. BRL is focusing on Bowie No. 2 in 2022.

The weather was clear and hot. The ground was dry.

#### HYDROLOGIC BALANCE - Rule 4.05

Drainage Control 4.05.1, 4.05.2, 4.05.3; Siltation Structures 4.05.5, 4.05.6; Discharge Structures 4.05.7, 4.05.10; Diversions 4.05.4; Effluent Limits 4.05.2; Ground Water Monitoring 4.05.13; Surface Water Monitoring 4.05.13; Drainage – Acid and Toxic Materials 4.05.8; Impoundments 4.05.6, 4.05.9; Stream Buffer Zones 4.05.18:

The ponds at the loadout and Coal Storage Area (near Black Bridge Road) were dry, and no problems were identified. Riprap ditches at the East Mine are stable.

Near the first bend in the haul road west of the RDA, straw bales in the ditch have been replaced.

## RECLAMATION SUCCESS - Rule 4.15, Rule 3:

No erosion was seen at the reclaimed areas of the East Mine, including:

- The main area along the haul road and around the old portals
- The RDA
- The Old Waste Disposal Area.

At the first bend in the haul road west of the RDA, the slope below the road was inspected. No erosion control practices are in place here, but the slope is generally stable.

REVEGETATION - Rule 4.15

Vegetative Cover; Timing:

In the area above the RDA, significant numbers of white top and cheat grass plants were seen.

SLIDES and DAMAGE - Rule 4.12:

The slope around the fallen fence at the upper part of the East Mine was stable.

OFFSITE SUPPORT FACILIITES - Rule 4.04, 4.28:

The slope below the loadout is stable. No erosion or other problems were seen there. The Farmers Ditch that flows through the loadout was flowing full at both ends of the long culvert (above and below the loadout).
