OBSERVATIONS

This inspection was conducted as part of the Colorado Division of Reclamation, Mining, and Safety normal monitoring program. The 2006-07 Geo-Hydro Drill & Core Program- Public-PRL's is a Hard Rock NOI located in Rio Blanco County. Amy Yeldell of the Division conducted the inspection. Samantha Baker represented the Operator. James Roberts of the White River Field Office was also present.

The permitted NOI includes a total of 3.88 acres and has a required bond of \$18,711. In 2020 AR-1 and in 2021 SR-1 were approved to reflect progress towards the completion of final reclamation. The Division still holds \$168,818.66 in financial warranty for this site since a replacement bond has not been submitted following the approval of SR-1. Following the approval of AR-1 the following pads remain permitted; 71-8-298 and 77-11-299.

All hydrology wells have been abandoned and pads have been reclaimed. The last reclamation efforts were completed in 2015 and now are awaiting adequate vegetation establishment. Reclamation efforts were completed in 2015 and now are awaiting adequate vegetation establishment. The past winter was extremely dry with very little snow/ moisture. This spring/ early summer has been very cold with limited precipitation. Generally plants are behind schedule in germination and inspection timing is more comparable to typical March/April site conditions. Wild horse populations have significantly increased and vegetation throughout the Piceance Basin is showing signs of overgrazing. Over all pads are stable with no signs of erosion. All mining related debris has been removed from the site(s). Specific observations of each pad are listed below,

- Pad 71-8-298: Culvert from the county road to pad has been removed. Desirable vegetation cover has significantly decreased since the previous inspection. Grazing pressures have drastically increased. The limited grasses have been eaten to the dirt. Cheatgrass populations appear to be increasing and pushing out the already limited desirable grass species. Evidence to recent weed treatments were observed. Hopefully summer monsoons will allow for desirable grasses to bounce back. The predominant cover type remains to be Rabbit brush which seem to be only minimally affected by grazing.
- Pad 77-11-299: Nearly void of all desirable vegetation. Overall grasses are extremely low and sparse due to heavy grazing. Very few shrubs have established. Woody material is not deterring grazing impacts nearly as much as surrounding pads. Evidence of recent weed were treatments observed. An exclusion fence or similar feature should be considered. Secondary seeding will likely be necessary to establish successful reclamation.


