OBSERVATIONS

This inspection was conducted as part of the Colorado Division of Reclamation, Mining, and Safety normal monitoring program. The Shale Core 2020-03 is a Hard Rock NOI located in Rio Blanco County. The NOI includes a total of 0.21 acres. Amy Yeldell of the Division conducted the inspection. Justin Bilyeu represented the Operator, Mahogany Energy Resources, LLC.

The mine identification sign and affected area boundary markers are in place and in compliance with Rule 3.1.12. A signs is posted as you enter the permit boundary.

In general the pad configuration and overall disturbance represented what was proposed and approved by the Division in the application materials. The pad is stable with no storm water or erosion concerns. No weeds were observed.

Both wells have been drilled. Recently one of the wells (core holes) has been permanently abandoned (plugged). Equipment has been installed on other the long-term monitoring well. The locking cap on the long-term monitoring well as yet to be installed but was observed on site. To date the Division has yet to receive the final abandonment report. Pursuant to Rule 5.7 the Prospector shall submit the final report within 12 months of completion of the abandonment of any drill holes

All drilling and abandonment related equipment has been removed form site. No other equipment, buildings, fuel or mining related debris remains on site. The cuttings pit from drilling still remains open, it will be reclaimed with the rest of the pad as part of reclamation. The Operator anticipates conducting initial dirt work this summer with seeding this fall (2022). The wire exclusion fence has not yet been installed but should occur closely after seeding occurs to protect reclamation from grazing.

The Division currently requires a financial warranty amount of \$8,517 for this site. In an effort to ensure the Financial Warranty adequately, reflects the actual current cost of fulfilling the requirements of the approved reclamation plan the Division has updated the reclamation cost estimate and found the current bond to be sufficient.
