Box 628, Nuck, CO 81424 has filed with the Division of Reclamation, Mining and Safety an application for Permit Revision No. 09 (PR-09) to the New Horizons Mine Permit No. C-1981-008. PR-09 proposes to change to the post mine land use by reclaiming a prime farmland area that was previously permitted as a dryland pasture area where existing infrastructure exists to adequately irrigate the prime farmland reclamation. PR-09 also proposes to revise the post mine land use of an area from dryland pasture to industrial.

The New Horizon Mine office is located at 27666 West 5th Street, P.O. Box 628, Nuck, Colorado. The permit area contains tracts of land located in Section 6, Township 46 North; Range 15 West; Section 31, Township 47 North; Range 15 West; Section 1 Township 46 North, Range 16 West; Section 47 Township 47 North, Range 16 West, of the New Mexico Principal Meridian, Montrose County, Colorado. The above-mentioned tracts of land are shown on USGS 7.5 minute Nucka Quadrangle map.
