Dear Mr. Trujillo,

Tri-State Generation and Transmission Association Inc. (Tri-State), is the parent company to Axial Basin Coal Company, which is the general partner to Colowyo Coal Company L.P. (Colowyo). Therefore, Tri-State on behalf of Colowyo is submitting minor revision 243 (MR-243) to Permit No. C-1981-019.

MR-243 proposes a topsoil windrow on the western crest of Little Collom Gulch within the Collom Pit. This topsoil will be windrowed at the crest of Little Collom Gulch near the cumulative bond boundary as shown on Maps 28 and 13C-1. When Colowyo's mining progression moves to the west and north on the west side to Little Collom Gulch, these windrows will be removed with a larger topsoil removal effort. Exhibit 13C has not been updated with this submittal as the volume of topsoil and disturbance area have already been accounted and are bonded for as approved under MR-240.
