Exhibit B - Site description

The attached information was obtained from the basic soils and vegetation information on the USDA's national soils information page and the soil survey of Otero County, Colorado.

The soil over the entire proposed mine location consists of Minnequa-Manvel silt loams, 1 to 6 percent dry slopes.

See appendix for photos of the site showing native grasses and vegetation.

On-site test holes indicate layers of shale rock begin 6-12" below the surface, and continue to an approximate depth of 30' below the surface.

Using information from Mr. Stoddard's well that was dug in 2008, we believe the depth of the shale rock to be approximately 30' below the surface. This well is located 465' to the west of the proposed mine site.

Man Made Structures

There are no man made structures within 200' of the site. The closest man made structure is a 70' X 140' metal shop building owned by John Stoddard. It is located 203' west of the west boundary of the site.

Water Resources

There is no water source located on the site. The closest well is located 465' west of the west boundary of the site. It is owned by John and Loretta Stoddard. It has a depth of 510'. The water table is located at a depth of 270'. Due to the depth of the water table, hydrologic balance will not be affected.

There are no streams, springs, lakes, stock water ponds, ditches, reservoirs or aquifers that would receive drainage directly from the affected area. Stormwater will remain on site due to the lack of slope, and will be allowed to soak back into the soil.

If water is needed for dust control it will be purchased from the city of La Junta. Stoddard Construction has an account with the city of La Junta, and currently uses a fire hydrant located on south San Juan Ave. for filling.

Stoddard Pit Exhibit C - Mining Plan

The site is located approximately 4.9 miles south of La Junta, CO, 1/4 miles west of Highway 109. The site and the land surrounding the site is owned by Stoddard Construction LLC of La Junta, CO.

This site will be used as an open pit mine. The site will be mined using a dozer and excavator. The material will be pushed up into stockpiles and then be hauled off for commercial purposes of road maintenance and building site pad construction. It is estimated that the open pit part of the mine will be no larger than 200' X 200' (.91 acres) at any one time. The material will be pushed from south to north, with material piled on the north end of the pit.

Upon completion of mining, the land will be reclaimed using over burden material and reseeded following a recommendation obtained from the NRCS office in Rocky Ford, CO. (see attached recommendation)

The material expected to be mined will consist of mostly shale rock. If the rock is smaller than 3" it can be used directly from the mine with out the need for crushing or screening.

Mining will start on the south end of the site and progress north. As Mining begins, trucks will enter on the south, and have access around the north side of the material as it is pushed into piles using a dozer and or excavator. The road will be a continuous loop, using one way traffic. Trucks will proceed east into the mine, proceed to the east side, turning north to continue around the north side and load facing south. Dirt berms will be placed along the edges of the mine, so as to prevent any traffic from driving off the edge of the mine hole.

As a means of preventing off site truck traffic, Mr. Stoddard will fence the mine site off from the surrounding rangeland.

As the depth of the mine increases, the rock layers are expected to be larger and may require crushing and or screening prior to being used as construction material. When mined material will need crushed, that material will be hauled to another site where it will be crushed, using a 3rd party company to crush as needed. Estimated depth of the shale rock to be mined is 30' below the surface.

It is estimated that there will be 6-12" of overburden to be pushed off to the side and used for dirt berms for safety and also for reclamation upon completion of mining. Overburden piles will be places to the east of the open pit and will be stabilized in place by natural overgrowth, although weed control will be monitored to prevent the spread of any noxious weeds.

The land is currently being used as rangeland by Mr. Stoddard and will continue to be used as such, if able, during the life of the mine. The expected life of the mine will be from 15-20 years based on usage of the material to be mined. Mining is estimated to begin between August 1st, 2022 and September 1st 2022. The material to be mined will be less than 70,000 tons per year.

The mining will start on the south end of the site and progress north. Of the 9.95 acres in the site, no more than 9.7 acres are expected to be mined, using .25 acres of the site as setbacks from the perimeter.

Access to the mine will be from an existing approach on Mr. Stoddard's property off of Otero County Rd. V.5., measuring 40' wide, then proceed thru the parking area to the south of Mr. Stoddard's shop, then into the south end of the mine, via an existing dirt road owned by Stoddard Construction LLC. This existing road is currently sufficient for truck traffic. This road into the mine will be maintained with material from the mine by Stoddard Construction LLC.

There will be no structures placed on site, nor do any structures currently exist on site.


