Mountain Coal Company, LLC (MCC) submits this response to the Adequacy letter dated June 29, 2022. Based off the Phase I inspection conducted on July 14, 2022 it was observed the road leading to E7-8 and 9 was reclaimed and needed to be added to the SL-15 table. MCC would like to include the section of road leading to E7-8 and E7-9 pad. The road is approximately .32 miles long at 14 feet wide making the total acreage for the road .55 acres reclaimed.

The new total number of acres reclaimed for SL-15 is approximately 8.2 acres. Please see attached updated tables and map.
