

PUBLIC NOTICE

BDF, LLC, 20965 Hwy 550, Montrose, CO 81403, (970) 209-4106, has filed an application for a Regular (112) Construction Materials Operation Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Land Reclamation Act for the Extraction of Construction Materials. The proposed mine is known as the Base Products Gravel Pit 2, and is located at or near Sections 13, Township 49 North, Range 10 West of the New Mexico Principal Meridian.

The proposed date of commencement is May 2023, and the proposed date of completion is October 2090. The proposed future use of the land is irrigated pasture and rangeland.
