## **OBSERVATIONS**

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. Barbara Hubbs, representing the Operator, was present during this inspection. Photographs are included with this report in order to illustrate conditions observed.

The Hubbs Pit is located approximately one mile east of Marvel and accessed from CR 133. The site is a 112c operation that includes a total of 28.52 permitted acres. The Division currently holds a financial warranty amount of \$59,905.00 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is sufficient.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by fencing that was clearly visible and adequate to delineate the affected area boundary.

The permitted area is divided into three mining phases. Phases 1, 2 and part of 3 have been mined out with the majority of the mining activity taking place in the northern section of Phase 3. The highwall in the north part of the Phase 3 area is approximately 10 feet high and near vertical to 1H:1V where sloughing has occurred.

The site undergoes contemporaneous reclamation as the mining activity progresses. At this time the southern section of Phase 2 as well as the southern and eastern sections of Phase 3 have been reclaimed. Phase 1 is currently being used as the stockpiling and staging area. The reclaimed areas have been sloped to approximately a 3H: 1V or less and appear stable. The vegetation throughout the reclaimed areas is adequate in both density and diversity. Noxious weed infestations were not noted.

No problems or violations were noted during this inspection.
