# **OBSERVATIONS**

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate conditions observed.

The Texas Creek Grav Pit is located approximately 13.5 miles east of Durango and accessed from CR 245. The site is a 110c operation that includes a total of 6.7 permitted acres. The Division currently holds a financial warranty amount of \$7,770 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is sufficient.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by fencing that was clearly visible and adequate to delineate the affected area boundary.

The pit daylights on the south and east sides. Most of the highwall on the west side of the pit has been regraded to 3H:1V and vegetative cover is becoming well established. A section of near-vertical highwall exists on the north end of the pit, approximately 100 linear feet at approximately 50 feet in height. Topsoil is in place above the highwall and in several piles within the pit.

No problems or violations were noted during this inspection.
