OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate conditions observed.

The Weaselskin site is located approximately 6.4 miles southeast of Durango and accessed from private drive off of Hwy 550. The site is a 110c operation that includes a total of 5.0 permitted acres. The Division currently holds a financial warranty amount of \$8,215.00 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is sufficient.

A mine sign or boundary markers were not noted at the site.

The site is in final reclamation. The slopes have been graded to 2H:1V. Vegetation on the slopes consisted of some native grasses, but was mostly kochia. The operator will need to perform weed control and reseed the site with the approved reclamation seed mix.

One stockpile of gravel remains on site.

No problems or violations were noted during this inspection.
