OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate conditions observed.

The Bayfield Pit No. 1 is located approximately 2.5 miles south of Bayfield and accessed from Buck Hwy. The site is a 112c operation that includes a total of 84.83 permitted acres. The Division currently holds a financial warranty amount of \$52,982.00 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is sufficient.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by fencing that was clearly visible and adequate to delineate the affected area boundary.

Mining was not occurring during this inspection. Processed material is stockpiled in the Phase 1 area and the Processing/Office area. Phases 1, 3, 5, 6 and 7 have been mined out. Slopes around these areas have been reduced to 3H:1V. Ponds were not dewatered during this inspection.

Noxious weed infestations were not noted. Erosional or stability issues were not observed.

No problems or violations were noted during this inspection.
