OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate conditions observed.

The Two Sheep for One Brick Mine is located within Paonia State Park and accessed from the Paonia Reservoir boat ramp. The site is a intermittent 110c operation that includes a total of 4.4 permitted acres. The Division currently holds a financial warranty amount of \$2,500 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is sufficient.

The operation removes sediment that accumulates in the reservoir for use in ceramics manufacturing. Excavation was not occurring during this inspection. Mining equipment is not stored on site. The excavation area is inundated seasonally and refills with sediment. The excavation area is indiscernible from the surrounding area.

No problems or violations were noted during this inspection.
