PROBLEM/POSSIBLE VIOLATION: Problem: The annual report and fee are past due for this site. The report and fee were due June 27, 2022.

CORRECTIVE ACTIONS: Submit the past due annual report and fee by the corrective action deadline.

CORRECTIVE ACTION DUE DATE: October 21, 2022

OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate conditions observed.

The J & J Pit is located approximately on the east side of Durango accessed from CR 3. The site is a 110c operation that includes a total of 9.0 permitted acres. The Division currently holds a financial warranty amount of \$47,390.00 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is sufficient.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by fencing and berms adequate to delineate the affected area boundary.

Mining was active during this inspection. The highwall on the north end of the pit has been regraded to 2H:1V and vegetation is becoming well established. In the northeast corner of the pit (Lot B area), mining is progressing to the east. The mined slope is approximately 1H:1V. South of that (Lot C area) mining is progressing south and east. The highwall in this area is near vertical.

Various stockpiles, mining and processing equipment are located within the pit area. Overall, the pit appears to be well maintained and orderly.

Each year, pursuant to C.R.S. 34-32.5.116 (3)(a), on the anniversary date of the permit, the operator shall submit the annual fee of \$323, a report and map showing the extent of current disturbances to affected land, reclamation accomplished to date and during the preceding year, new disturbances that are anticipated to occur during the upcoming year, reclamation that will be performed during the coming year, the dates for the beginning of active operations, and the date active operations ceased for the year, if any. The anniversary date for this permit is June 27. To date, the operator has not submitted the annual report and fee that were due June 27, 2022. This has been noted as a problem on page one of this report.

No other problems or violations were noted during this inspection.
