The Caribou Park project was done in the area of Caribou Road, however we didn't use any dump trucks. Just pickups with trailers to pull the mini-ex around, and one trip in in the am, one out in the pm. We wrapped up work in that area 9/30/2022 and moved over to the Eldora side (which is now complete as well). I was behind a semi truck on 10/3 as I was going up to do my last inspections of the area that was stuck just past the Cardinal Mill, but it appeared to be a moving van of some kind, not mine related. I personally have not observed any dump trucks coming or going while I have been on the road.
