Dear Ms. Reilley:

Attached is Trapper's Permit Revision 11 application for the five-year permit term, 2023-2027. Also attached is a copy of a newspaper public notice for the Craig Press and a revision application form to our existing coal mining and reclamation permit. This permit revision proposes to disturb an additional 295 acres within our approved permit area during the PR-11 permit term. This revision also proposes expanding the permitted mine area by 137.1 acres on the NW corner of the site.

Permit Revision 11 proposes to update the mining and reclamation plans for the upcoming permit term. Included in this update are several notable proposed changes. In the L-Pit, two additional dip-line and several additional strike-line cuts at the south end of the pit will be completed. In the western portion of the mine, I and J-Pits will continue to be opened towards the west in sections and highwall mined. A new pit area, called C-Pit will be opened down dip of the previously mined C-Pit. This pit will also be an east to west cut that will be highwall mined. In the NW corner of the permit area, I West-Pit will be opened and will require the expansion of the permit boundary to the north. New mining in the western portion of the site will require the construction and or modification of three sediment control structures.

During the 2023-2027 permit term, continued reclamation of the site is proposed and will encompass finishing the D-Pit reclamation, a piece of the Ash-Pit and the majority of the active areas in C, I, J, L and N-Pits before the end of the permit term, (refer to M10 series maps).

Enclosed with this letter is a five-page cross-reference index of all changes to text and maps proposed with this revision. Included with the cross-reference index is a brief description of each proposed change and, as appropriate, brief comments are added.
