Adequacy Review Item #3

Please find attached an email correspondence with Troy Florain, DOW. In this the email Mr. Florain commented that there is a new regulation to be adopted soon that suggests not beginning new construction between January 1st and April 30th for Pronghorn wintering areas. We discussed how this site has already begun construction as it is part of the VIP Industrial Park Subdivision. Mr. Florain stated that this new regulation should not apply to this site.

Mr. Florain

We spoke today about a new gravel permit in Nunn, CO on the Varra property called the VIP Mine. You suggested that I write this email describing our conversation so that you can confirm it.

As we discussed, Mr. Rob Zuber, Division of Reclamation, has provided a couple of items for clarification on our 112 mining permit. Mr. Zuber has asked us to ensure that you are aware of the new gravel mine and if you have any conditions for this mine.

You stated that you would like to have the side slopes of the pit to be at a grade that allows for pronghorn to exit the pit if they stray into it. I suggested 3:1 side slopes and you stated that that is adequate.

You asked what type of fencing will be around the site and I stated that we did not intend to build fencing around the site. We have put up "T" post approximately every 800 feet to mark the boundary and at the property corners. We have also installed temporary silt fencing along the south property line. You stated that was fine.

You stated that there is a new regulation to be adopted soon that suggests not beginning new construction between January 1st and April 30th. We discussed how this site has already begun construction as it is part of the VIP Industrial Park subdivision. You stated that this new regulation should not apply to this site.

You asked about the reclamation process. I stated that we are beginning at the east end of the site and working west and then north. We anticipate mining approximately 10 acres per year. As we move west and north, we will provide reclamation reseeding beginning at the east end of the site. You stated that this is a good plan.

We also discussed plant species for reseeding. You stated that you do not have a recommendation for reseeding as long as it is a native dryland prairie species. You requested a large variety of species to be planted. I have tried to contact the West Greeley Conservation District for some plant species and reseeding recommendations. On their website they recommend Blue Grama, Buffalo grass, Sideoats Grama, and Western Wheatgrass. The NRCS recommended that we use slender hair grass, slender wheat grass and annual hairgrass in our permit application. We will gladly use a variety of any and all. We are waiting for recommendations from the West Greeley Conservation District.

I believe this covers our conversation today. Would you please respond with confirmation of this email?

Your summary looks accurate from what I recall. As for any clarification on the operational weed management and post operational vegetation reclamation... I believe you mentioned that there will be a construction and operational weed management plan throughout construction, and a vegetation reclamation plan once everything is complete. In terms of the seed mix for reclamation, I'd like to clarify that it would be preferred to target a mix of native plains cool and warm season grasses containing a variety of forbs / pollinators species unless there is cultivated ag planned by the landowner.
