Dear Mr. Mason,

The Colorado Division of Reclamation, Mining and Safety (DRMS or Division) received Minor Revision No. 132 (MR132) on August 19, 2022 from New Elk Coal Company, LLC (NECC). MR132 was deemed complete and filed on August 22, 2022. The Division is required to issue a decision on the application by November 18, 2022. NECC responded to the Division's second adequacy review on October 24th, 2022. The following adequacy issues listed below were identified in the Division's second adequacy review letter. Adequacy items that have been resolved have been deleted from the list, issues that remain outstanding or if additional information is needed are discussed below. Please address the following issues:

Rule 2.03.4 – Identification of Interests

- A. The Owners of Surface and Subsurface Contiguous to the Permit Area listed on revised page 9-12 is not reflective of the currently approved permit area and appears to include owners from the proposed expansion area from PR5. Please revise these pages to list the Owners of Record of surface and subsurface within or contiguous to the current permit boundary as shown on approved Maps 1 and 2.
 - a. NECC Response: Pages 9-12 have been corrected.
 - **b. DRMS Response:** NECC's revised list does not include owners of the Jansen Loadout area and the Golden Eagle Fan Site. Please revise the table on proposed revised page 9 and 10 to include these owners.

Rule 2.03.5 – Compliance Information

B. Attached is a report dated November 1, 2022 form the Applicant/Violator System (AVS) from the Office of Surface Mining, Reclamation and Enforcement (OSMRE). The report indicates Black Warrior Minerals, Inc. was cited for a recent violation in August of 2022. Therefore, please update permit Section 2.03.5(1)(c) with the information required by Rule 2.03.5(1)(c) pertaining to this violation.



Rule 2.03.6 - Right of Entry Information

- C. Proposed revised page 11 still cites PR-05 in the fourth sentence under section 2.03.6. Please revise this sentence to remove the citation of PR-05.
- 7. Technical Revision No. 76 (TR76), currently under review by the Division, includes proposed revisions to section 2.03 of the PAP; it is likely TR76 will be approved and issued first before MR132 is approved and issued, therefore please make sure the revisions to section 2.03 in MR132 are reflective of TR76. For example, please update proposed revised page 12 with an accurate disturbance acreage for the proposed haul road under consideration for TR76.
 - a. NECC Response: All revised sections of 2.03 have been revised to reflect the approval of TR 76.
 - b. **DRMS Response:** The revised text on proposed revised page 15 regarding TR76 is not reflective of what was approved. Please update this page with the approved text.
 - c. NECC Response: Now page 13 has been revised.
 - d. **DRMS Response:** The revised text on proposed revised page 13 regarding TR76 is not reflective of what was approved. Please update this page with the approved text.

2.03.10 Identification of other Licenses and Permits

D. The footer on revised page 16 of section 2.03 cites PR-5, 09/29/2021. Please revise this to indicate MR132 and the correct date.

The Division is required to issue a decision on the application by November 18, 2022. If you need additional time to address the Division's adequacy review items, please request an extension of the decision date. If the decision date arrives and there are outstanding adequacy review items, the Division will issue a proposed decision to deny the application.
