## **OBSERVATIONS**

This inspection was conducted in response to the Succession of Operator Application (SO-2). Amy Yeldell of the Colorado Division of Reclamation, Mining and Safety (Division) conducted the inspection. The White River S & G Pit is a 110c gravel pit that includes a total of 6.7 acres. The site located in approximately 1.5 miles east of Meeker Colorado. Kent Borchard the landowner was present for the inspection.

Significant reclamation progress has been made since the Division's last inspection on May 24, 2022. All mining related debris has been removed from the site and only equipment remains on site. All highwall slopes have been properly graded to a 2H: 1V or less and topsoil has been reapplied. Seeding has not yet occurred and is scheduled for this spring. The misc. stockpiles on the pit floor have all been graded out flat and are stabilized with remaining gravel. There is a drainage ditch along the east side of the pit conveying stromwater from CR 8 through the pit to a sediment pond on the southeast corner. A small berm has been left along the western edge of the pit floor to create a bowl, preventing run-off from going directly into the river adjacent to the permit.

The incompleteness response received by the Division on September 27, 2022 addresses all of the remaining SO-2 application requirements. Only posting of the required financial warranty remains. The Division currently requires a financial warranty amount of \$33,814.20 for this site. In an effort to ensure the Financial Warranty adequately, reflects the actual current cost of fulfilling the requirements of the approved reclamation plan the Division has updated the reclamation cost estimate. Actual site liability is estimated to be approximately 20k. The current permitted may request a Surety Reduction prior to the transfer. Otherwise the Prospective Operator will have to post the current bond amount of \$34K then request a reduction after the permit has been transferred. Lastly, after the approval of SO-2 the Operator may submit an amendment application to change the post mining land use.
